Dear Applicant,

Thank you for your interest in renting from AJ Apartments. A list of all of our currently available and coming available properties and the rules for each property is available online at www.AjApartments.com under the rental requirements tab. We have different apartment sizes, ranging from Studios to a 3-bedroom unit. All of our units participate in the Crime Free Housing program, are non smoking and do not allow pets. Our goal is for each of our apartments to provide the following:

- A clean and safe place for you and your family to live
- A place where all appliances, fixtures, and systems are in good working order
- Prompt response to every submitted work order

Completed applications are reviewed in the order they are received. Any application not completely filled out, or not containing the required documents, will be rejected and returned. Once the application has been reviewed and accepted, an applicant has 48 hours to sign the lease or provide a non-refundable holding deposit to secure the unit. The unit is not unlisted for rent until the hold deposit or lease is signed.

Rental Requirements:

- **Verifiable** combined monthly income at least 3 times monthly rent
- No evictions/forcible detainers in the last 48 months
- No felonies/criminal history
- No pets
- No-smoking/vaping of any type

Required Documents:

- Photocopy of a valid, current photo ID (driver's license, military ID, or State ID)
- A copy of the last 2 pay stubs for all income
- \$35 non-refundable application fee (check or money order made out to AJ Apartments LLC)
- All paperwork for a service animal if you have one that will be living in the apartment

Please review these requirements carefully before completing and submitting your application. Every section must be completely filled out, write N/A if it does not apply to you. Each resident over 18 years old must fill out an application, include all required documents and be submitted together. If you have any questions, please feel free to call or email us.
